In December 2011, Alabama's last state-operated institution for persons with developmental disabilities, Partlow, closed its doors and discharged the last residents to appropriate, community placements. Since Partlow's closing, ADAP has focused its efforts in ensuring persons with developmental disabilities in community placements are receiving appropriate services and are free from abuse and neglect.

ADAP has monitored persons with developmental disabilities in their group homes, day habilitation programs, and sheltered workshops. If you have concerns about a person with developmental disabilities and the treatment they are receiving in a community program, please call, 1-800-826-1675, or email, adap@adap.ua.edu. ADAP can make an unannounced monitoring visit to the community program and/or conduct an investigation into the person's situation.
