## ADAP Proposed Priorities FY 15-17

### **Priority 1: Consumer and Self-advocate Engagement**

ADAP will strengthen the disability civil rights movement in Alabama by supporting and empowering persons with disabilities to speak for themselves and address policy and programming decisions that affect them.

### **Priority 2: Well-being in Facilities**

Adults and youth with disabilities in congregate and residential facilities will be free from abuse and neglect and civil rights violations.

### **Priority 3: DD Definition**

The State of Alabama will expand its definition of developmental disabilities (DD) to include and serve persons with all types of DDs.

### **Priority 4: Medicaid Managed Care**

Adults and youth with disabilities will receive appropriate medical care and treatment.

### **Priority 5: Nursing Homes**

End unnecessary institutionalization of adults and youth with disabilities in nursing homes.

### **Priority 6: Integrated Employment**

Adults and youth with disabilities will have meaningful access to integrated employment and be paid at least minimum wage.

### **Priority 7: Mental Health**

Adults and youth with mental health and behavioral disorders will receive appropriate care in the most integrated setting.

### **Priority 8: Community Access**

Adults and youth with disabilities will have full physical and program access in all aspects of community life.

### **Priority 9: Education**

Youth with disabilities will receive a free appropriate public education in their least restrictive environment.





## Special Education in Alabama: A Right Not a Favor



ADAP is pleased to announce the publication of the newest edition of its popular special education parent manual – “Special Education in Alabama: A Right Not a Favor” (RNF).

RNF helps families and child advocates understand how to access special education services and ensure that eligible children with disabilities are provided the free, appropriate public education to which they are entitled. The manual is written in lay-friendly terms and is filled with helpful advocacy tips and resources.

Publication of RNF was underwritten by a generous grant from the [Alabama Council on Developmental Disabilities](#).

The first edition of RNF was published in the mid-80’s. Since its last revision and printing in 2007, 50,000 free copies have been distributed across the state.
