Children and Youth with Special Health Care Needs



The Department of Children's Rehabilitation Services (CRS) wants to know how it can improve Alabama's system of care for children and youth with special health care needs (CYSHCN).

CYSHCN have, or are at increased risk for, chronic physical, developmental, behavioral, or emotional conditions, and require more health and related services than most children. Almost 26% of households in Alabama have one or more CYSHCN; the national rate is 23%.

The Department has developed three separate on-line surveys, one each for **families, youth** and **providers**. Please take a few minutes and let CRS know what you think of the needs of these children and their families.

U.S. Department of Justice to Celebrate 15th Anniversary of Olmstead



On June 22, 1999, the United States Supreme Court held in *Olmstead v. L.C.* that unjustified segregation of persons with disabilities constitutes discrimination in violation of Title II of the Americans with Disabilities Act. This landmark Supreme Court decision requires states to eliminate unnecessary segregation of persons with disabilities and to ensure that persons with disabilities receive services in the most integrated setting appropriate to their needs. To celebrate the 15th anniversary of this important ruling, the U.S. Department of Health and Human Services (HHS) and the U.S. Department of Justice (DOJ) will hold an event on Friday, June 20, 2014, from 1-2:30 pm in the Great Hall of the Hubert H. Humphrey Building.
