Will Your Voice Be Heard On Election Day?



One of ADAP's annual priorities is to advocate for participation in the election process by persons with disabilities. ADAP receives federal funds specifically to promote the rights of persons with disabilities to exercise their right to vote.

ADAP attempts to accomplish the goal of participation in the election process by persons with disabilities in a number of ways: 1) training persons with disabilities on their rights to have an accessible election process; 2) educating election officials about the rights of persons with disabilities to have accessible polling sites and voting machines; 3) providing poll workers with information on appropriate ways to interact with persons with disabilities; and 4) surveying polling sites to make sure they are fully accessible. During the current year, ADAP is focusing its efforts in ensuring persons with disabilities are able to fully participate in the mayoral elections in Birmingham, Huntsville, and Tuscaloosa. Mayoral elections in each city will be held on August 27, 2013. If you are not already a registered voter, you must register to vote by August 16, 2013 in order to vote in the 2013 mayoral election.

According to a 2011 report, voter turnout among persons with disabilities is between 4 - 21% less than persons without disabilities. The full report can be accessed here. The most important thing persons with disabilities can do in any election is let their respective voices be heard by voting.
